This Greater London Authority site spans London boroughs, delivering 3,000 new homes and a mix of other uses such as a new train station, community hub, energy centres and two new schools.

Our collaborative approach overcame various challenges including contamination remediation, flood risks, extensive existing utility infrastructure and noise issues to secure planning permission.

LOCATION: Warrington, Cheshire

Stantec was commissioned to provide planning and environmental services for this 3.2km link road which crosses railway viaducts and a number of several waterbodies including the Manchester Ship Canal and the River Mersey.

The new road will relieve congestion, improve traffic flow, unlock key development land and improve the quality of life for residents within the borough.

In addition to co-ordinating the Environmental Statement, our commission included inputs from our in-house specialists including landscape, ecology, hydrology, air quality and noise.

The scheme will include a new crossing of the Manchester Ship Canal

CARLESS SITE DEVELOPMENT, OLD KILPATRICK



LOCATION: Clydebank, Scotland

Stantec provided environmental coordination and planning strategy advice for the regeneration and transformation of a heavily contaminated site back to industrial use. The site was heavily contaminated due to oil in soils and floating on ground water from a former oil terminal, previously severely damaged during the Clydebank Blitz.

Coordinating a multidisciplinary approach (including detailed site investigation and remediation, an update of the River Clyde Flood Model and a new foul and surface water drainage strategy), and through consultation with multiple sensitive stakeholders, we prepared an EIA Report adopting a bespoke methodology to address the future baseline.

This submission also supported a concurrent planning and marine license application.
Ultimately, the proactive and novel approaches undertaken unlocked this heavily contaminated site for new industrial use.
